PRIVACY POLICY

Any capitalized terms used in this Privacy Policy are to be attributed with the same meaning attributed thereto under Lidl's CHEER WITH LIDL Lottery's Terms and Conditions available at https://www.lidl.com.mt/cheerwithlidl-lottery-TC unless otherwise defined herein.

For the purposes of this Privacy Policy, the terms "We, "Us", "Our" refer to LIDL Malta Limited. This Privacy Policy applies to your participation in Our CHEER WITH LIDL Lottery.

For the protection of your and Our rights and to ensure compliance with any and all applicable legal requirements, we may update and/or amend this Privacy Policy in our sole discretion and, should We elect to do so, We shall contact you by email at the email address provided to Us when registering your participation with Us.

1. Controller Details

The controller of your personal data is Lidl Malta Limited, a company registered in Malta, bearing company registration number C36317 and registered office at Vassallo Business Park, Burmarrad Road, Naxxar NXR 6345, Malta.

2. Categories of Personal Data

The term "personal data" refers to any and all personally identifiable information about you and includes all the information you provide to Us, and which is identifiable by Us, when participating in Our Lottery, as well as all other information which may arise that can be identified with you personally.

This include:

- a. Your Instagram username and user ID;
- b. the date, time, and text of your Instagram comment.

You will only be asked to provide additional information if you are a winner of a prize, in order to ensure your identity and to claim your prize. This will includeyour name, surname, date of birth, e-mail address, mobile phone number and any and all the information stated on your identity document, including a copy thereof, as well as on a declaration signed by you stating that you are not an employee of Lidl and that you had reached the age of 18 before entering the lottery.

3. Purposes of Processing

Your data will only be processed for "the Intended purposes" under this policy or as may be required to defend any legal claim that may be brought against Us or any of the listed processors of your personal data; or as may be ordered by any judicial or quasi-judicial authority or any government authority.

The intended purposes of processing of your personal data are:

- (i) Giving effect to the Terms & Conditions (T&Cs) concluded with Us (including the taking of any and all steps necessary to enter into the T&Cs or to implement any updates or amendments thereto) with regard to your participation in the Prize Draws or anything relative or ancillary thereto; and
- (ii) validating your identity before delivering your Prize.
 Accepting the awarded prize will require accessing a registration platform and providing mandatory personal data for the individuals who will benefit from the prize. This data will be used solely for organizational purposes. The platform's terms and conditions, as well as the specific privacy policy, will thoroughly explain this process. However, refusal to provide personal data will result in the impossibility of accepting the prize.

4. Legal Basis

Our legal bases of processing your personal data are:

- (i) Entering into and performance of a contract as a result of your participation in Our Lottery and subsequent entry into Our Prize Draw. Providing such Personal Data is necessary for your participation in Our Prize Draw. The consequence of not carrying out such Processing would be that you would be unable to participate in the Prize Draw;
- (ii) Your explicit consent in which case, Our Processing shall be limited to the purposes specifically indicated when your consent was requested;
- (iii) Compliance with legal obligations imposed on Us; and
- (iv) Our or a third party's legitimate interest.

We might also have to process your data to exercise or defend legal claims. Such processing would be carried out in reliance on Our, or a third-party legitimate interest. In such a scenario, We shall ensure that your interests and fundamental rights and freedoms which require protection of personal data are respected.

5. Recipients

The recipients of your personal data will be:

- a. selected individuals within Our company;
- b. our intra-group companies and affiliates who process the personal data as data processors, including
 Lidl Italia S.r.l. a socio unico located at Via Augusto Ruffo 36, 37040 Arcole (VR), Italy, Lidl Stiftung &
 Co. KG located at Stiftsbergstraße 1, 74172 Neckarsulm (Germany);
- our agents and third parties that provide services to Us as data processors, including but not limited to JP Advertising Limited located at JPA, Msida Valley Road, Msida MSD 9020, Malta.;
- d. the Malta Gaming Authority as independent data controller, located at the Malta Gaming Authority
 Building SCM 02-03, Level 4, SmartCity Malta, Ricasoli SCM 1001; and
- e. third parties to whom disclosure may be required for your participation in the Prize Draw.

 Individuals with access to your personal data shall be subject to the same limitations under this Privacy Policy and are located within the European Union (EU) or the European Economic Area (EEA), including Ireland and

the Netherlands where the server hosting the Customer's personal data is located.

The general public who visit the competition section of Our website or Our Facebook and Instagram social media pages will **only** be able to access your data if you have consented to your data being published there.

6. Processing Requirement

The processing of your personal data is not a statutory requirement: it is a requirement in order to register your participation in the Prize Draw. Failure to provide your personal data impedes Us from being in a position to register you and allow you to participate in the Prize Draw.

7. Automated Decision-Making and Profiling

Your personal data will not be used for any automated decision-making or profiling.

8. Source of the Data

As part of your successful participation in Our Lottery, you may have been requested to submit personal data pertaining to another individual. We have a right to inform said individual that you were the person who passed on his or her personal data to Us in compliance with the T&Cs of the Lottery.

9. Data Retention Period

Your personal data shall be held throughout the duration of the Prize Draw and in any event, until no later than 30th June 2026. Thereafter, it shall be immediately and irrevocably erased unless We need to keep your personal data to comply with any legal obligation, or to exercise or defend any legal claim. Your identity document, which may be required in order to verify your status will be deleted immediately after the confirmation of the data without any copy being retained.

10. Your Rights

For as long as We retain your personal data, you may (where applicable):

- a. request access to and rectification of personal data where incomplete or inaccurate;
- b. request erasure of your personal data;
- c. object to the processing of your personal data;
- d. request to be informed of the source from which your personal data originates, if your personal data was not provided to Us directly by you;
- e. request that we provide you with any personal data you have provided us, in a structured, commonly used and machine-readable format; and
- f. request that we transmit your personal data directly to you or to another controller indicated by you.

To the extent that the legal basis for our processing of your personal information is your consent, you have the right to withdraw that consent at any time. Withdrawal will not affect the lawfulness of processing by Us at any point prior to the withdrawal nor Our right to retain your personal data in terms of Clause 9 above.

11. Complaints

If you have any complaints regarding our processing of your personal data, please note that you may contact Us or Our Data Protection Officer at the details indicated above. You also have a right to lodge a complaint with the Office of the Information and Data Protection Commissioner in Malta (www.idpc.gov.mt).

12. Changes to this Privacy Policy

We will keep this privacy notice under regular review. If there are any changes to this Policy, we will replace this page with an updated version on our website on www.lidl.com.mt. At the start of this page, we will tell you when it was last updated.
