

# Lidl Plus Stampcard Reward

## OFFICIAL RULES TERMS & CONIDITIONS

**Lidl Malta [LIDL]** is pleased to introduce the **Lidl Plus Stampcard Reward**, a special promotion designed to reward our valued customers. Please read the following rules carefully to understand how this promotion works and how you too can earn your fantastic rewards.

## Promotion Period

The Stampcard Reward is valid from **October 13 to November the 2<sup>nd</sup>, 2025**.

The scheme is available throughout all **Malta and Gozo** exclusively during this period.

## How It Works

### Eligibility:

The promotion is open to all registered and active **Lidl Plus** customers resident in Malta and Gozo.

After the access in the app, the user will see a pop-up window on the home page, and they will be asked to click the "Collect now" button to participate in the activity.

Customers must identify themselves at the checkout and scan their Lidl Plus card prior to the completion of the purchase.

The Lidl Plus will automatically register the purchase and the items contained – registering automatically the purchase of items that fall within this promotion.

Any purchase effected at which the Lidl Plus is not scanned correctly at check-out will be lost without the possibility of updating the users account during a second instance.

### Earning Stamps:

During the promotional period, customers will receive 1 stamp for every €2 spent on Favorina products.

The Favorina range is LIDL's selection of typical Christmas sweets, such as panettone, chocolate and biscuits.

## Redeeming Rewards:

For every **5 stamps collected** (equal to €10 spent on Favorina products), customers will automatically receive a coupon for one free Mini-Panettone (**100% discount**).

Coupons will be issued directly in the Lidl Plus.

When opening the app, a banner will appear on the homepage. Tap "**Collect now**" to join the promotion. Once you accept, the stamp collection section will be visible on the homepage for as long as the promotion is active. If you don't accept the prize promotion right away, you can always join later by tapping the "**Collect now**" button on the banner located on the homepage.

The user can redeem the coupon on the next purchase. They must activate it by clicking the "Activate" button and then identify themselves by scanning their digital Lidl Plus at the scanner before making the payment at the checkout. The coupon provides a free Mini-Panettone Favorina, which must be picked up in the store and presented at the checkout.

Please note that a maximum of 100 coupons can be displayed in the coupon section at any one time. If a user is entitled to more than 100 coupons, the additional coupons will automatically appear after the user has redeemed some of the existing ones, which will reduce the number of coupons in the section.

Lastly, any user can activate and redeem a maximum of 5 coupons in one shopping instance. Should the user hold more than 5 coupons, they will receive the free Mini-Panettone in the app with the balance [total less the 5 coupons] remain visible for them to benefit from in a second instance.

## Multiple Rewards:

Each customer can redeem more than one reward during the same period, for example:

- €10 spent = 5 stamps = 1 free Mini-Panettone coupon
- €20 spent = 10 stamps = 2 free Mini-Panettone coupons

## Important Notes

- Stamps are awarded only for purchases of **Favorina** products made during the promotional period.
- Coupons are valid only in accordance with the terms stated in the Lidl Plus .
- Coupons are valid for a 7 day window from receipt.
- A maximum of 5 coupons can be activated simultaneously in the Lidl Plus.

- Once the promotional period is over, any unused-accumulated stamps will be lost and cannot be carried over to a any future promotion.
- This promotion is non-transferable and has no cash alternative.
- LIDL reserves the right to amend, suspend, or terminate the scheme at any time in case of unforeseen circumstances.
- Offer valid until stocks last.
